***trafficking in persons human trafficking and modern slavery are umbrella terms often used interchangeably to refer to a crime whereby traffickers exploit and profit at the expense of adults or children by compelling them to perform labor or engage in commercial sex human trafficking also called trafficking in persons has no place in our world as both a grave crime and a human rights abuse it compromises national and economic security undermines the rule of law and harms the well being of individuals and communities everywhere investigations human trafficking investigations are conducted by agents within the human trafficking program and members of our task forces investigations often begin through tips from human trafficking also known as trafficking in persons is a crime that involves compelling or coercing a person to provide labor or services or to engage in commercial sex acts the coercion can be subtle or overt physical or psychological human trafficking and trafficking in persons are umbrella terms used to refer to both sex trafficking and compelled labor relevant u s and international law describe this compelled service using a number of different terms including involuntary servitude slavery or practices similar***
